STATE TEACHERS' AWARD - 2021

A great teacher and philosopher Dr. Radha Krishnan's (former President of India) birthday is celebrated as Teachers' Day every year on 5th September. It would be a proud privilege to salute & honour the teachers for their dedication and remarkable work who break down the barriers to reach into the souls of the students with love, devotion and care.

The teachers working in Govt. / Govt. Aided / Recognized Unaided Private /MCD/NDMC/Delhi Cantonment Board (DCB) Schools are eligible to apply. The selected teachers are rewarded with a cash award of Rs. 25000/-, A Citation, A Silver Medal and A Shawl. There are 116 awards for HOSs, Teachers, Librarian and Sports Teachers.

REVISED GUIDELINES FOR STATE TEACHERS' AWARD-2021

- All the Teachers of Primary, Middle, Secondary & Senior Secondary Schools of GNCT of Delhi/DOE/DOE Aided/DOE Un-Aided/MCD/MCD Aided/MCD Un-Aided/NDMC/NDMC Aided/NDMC Un-Aided/DCB schools who have completed at least 03 years of service as teacher by 31st March, 2021.
- > The teachers who have already got State Teachers' Award are not eligible.

- For Govt. and Govt. Aided Schools, the Heads of Schools who have got Excellence in Education Award in any category, can apply for State Teachers' Award only after a gap of three years.
- Educational Administrators are not eligible for this award. However, Principals/Vice Principals are eligible.
- The teachers, Vice Principals or Principals who have retired on or after 31st March 2021 (full academic session i.e. 2020-21 are eligible).

PROCEDURE FOR APPLICATION

- (a) Heads of Schools and Teachers themselves shall apply directly by filling the application form online on the official website of Directorate of Education.
- (b) All the online applications for State Teachers'Award-2021will be submitted in the respective category of school, namely:-
 - (i) Big Schools having Students' Enrolment: Above 2,500 Students
 - (ii) Medium Schools having Students' Enrolment: From 1,000 to 2,500 Students.
 - (iii) Small Schools having Students' Enrolment: Below 1,000 Students.
- (c) Every applicant shall submit a portfolio, online along with the Entry Form. The portfolio shall include relevant supporting material such as documents, tools, reports of activities, field visits or photographs etc.
- (d) Undertaking by the applicant: Each applicant shall give an undertaking that all the information/data submitted is true to the best of his/her knowledge and if anything is found at any later date to be untrue then he/she will be liable to disciplinary action.
- (e) The applications in r/o Teachers and Librarians will be duly verified and forwarded to the District Level Committee by the Heads of the Schools online after the submission by the applicant.
- (f) The applications in r/o HOSs will be verified by the DDE (Zone).

FUNCTIONS TO BE PERFORMED BY DISTRICT LEVEL COMMITTEE

The above committee at District Level will award marks on the basis of Rubric/ Marking Scheme provided, solely on the basis of availability of documentary evidences and its veracity.

While forwarding the duly evaluated applications, the District Level Committee should ensure that a minimum of 60% and above marks/ 75% and above for RPVV and SOE (School of Excellence) has been scored by the applicant.

After awarding marks, the District Level Committee (DLC) will forward online the application to the Awards Branch, Head Quarter.

DDE (District) will forward only those cases which are clear from Vigilance angle.

In case of Principal and Vice Principal, the District DDEs must furnish the Vigilance Clearance report of GOC (H.Q.) and DOV along with District Vigilance Report, issued only for the purpose of State Teachers' Award - 2021.

In case of Teachers/Principals/Vice Principals of Govt. Aided /Recognized Unaided Private Schools, the vigilance clearance certificate will be furnished by the Chairman/Manager of the school.

New pro formas for Heads of Schools, Teachers (including all categories i.e., PGTs, TGTs, Assistant Teachers, Nursery Teachers, Teachers of Miscellaneous Category, Contractual Teachers under SS/ Guest Teachers) and Librarian are online. The pro formas for remaining categories of Teachers i.e. Sports Teachers, EVGCs, Core Academic Unit, Special Education Teachers and Mentor Teachers will be offline like previous year.

ELIGIBILTY CRITERIA

- The teachers who have already received the State Teacher Award are not eligible.
- In the case of HOS who have received Excellence in Education Award in any category during last three years are not eligible.
- 3. Eligibility criteria is separately attached with all the relevant pro formas.

PROCEDURE FOR APPLICATION

- 1. The applicant must read the Circular/ Guidelines carefully before filling in the *pro* forma.
- 2. The applicant must apply **only in one category** i.e. any one from *Pro forma* A to D.
- 3. All the applications must be submitted on the prescribed pro forma only, mentioning page numbers for each and every point in the index, including all supporting documents/annexures clearly. The applicant will also submit two passport size photographs, self-attested supporting documents alongwith a brief write up about their achievements in the field of education, Vigilance Clearance Report at District Level and submit to the HOS of their parent school/ present school.

- 4. The supporting documents must include relevant supporting materials such as documents, tools, reports of activities, field visits or photographs etc.
- 5. A certificate must be taken from the next Higher Authority of the applicant, after the verification of record, that the applicant has not received 'State Teachers' Award' earlier and 'Excellence in Education Award' during last three years (Annexure-1 for Teachers/ Vice-Principals/ Principals).
- 6. The applicant must certify that all the information furnished by him/her is correct. Any wrong information given by the applicant will attract disqualification and disciplinary proceeding.

PROCEDURE FOR SUBMISSION

- The HOS must ensure that all the columns in the *Pro forma* are duly filled in, by the applicant. The information filled-in should be verified from teacher's diary, inspection report, annual result of the school and the service book of the applicant etc.
- 2. The HOS will countersign all the applications on every page, after verification of all the supporting documents/ annexures and the same is to be forwarded to the DDE (Zone).
- 3. The DDE (Zone) must ensure that every page of *pro forma*/ annexures are verified, countersigned and certified by the HOS of concerned school.
- 4. DDE (Zone) will forward all the applications/ nominations of teachers, to DDE (District).
- 5. Applications in r/o HOS will be verified and countersigned by the DDE (Zone) alongwith supporting documents/ annexures, and will forward to DDE (District).

- 6. Further, the DDE District will forward only those applications to the branches/ District office concerned, which are clear from vigilance angle.
- 7. In the cases of HOS, the Vigilance Clearance Report of GOC (H.Q.) and DOV along with District level Vigilance Clearance Report, issued only for the purpose of State Teachers' Award 2021, is mandatory.
- 8. All the applications for award (refer *Pro forma* A to D) are to be forwarded by District DDEs to the Branches concerned.
