2. Participation without registration will not be accepted on the day of the event.
3. Registration will be done only ONCE for all the events.
4. The participants are required to register on the respective link of each event given in the Event Calendar latest by **30th November, 2022.**
5. The participants are expected to report by **8:15 a.m. on 7th December 2022** for verification of details at the Registration Desk.
6. On arrival, the participating team must submit a certificate signed by the Principal of the school concerned, certifying that the participants mentioned are its bonafide students.
7. All the events will commence at **9:00 a.m. sharp.**

14. For any queries related to the event, kindly coordinate with the event Incharges of the specific event between 4:00 p.m. and 6:00 p.m. through WhatsApp.

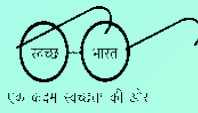

Duration	:	2.5 – 3 Minutes
Topic	:	

- ❖ Quality of Education is an ambiguous and inarticulate paradigm.
- ❖ Judiciary is shaped by the desires of political conglomerates.
- ❖ Co-authorship of the global innovation is fragmented at the root.
- ❖ The paradigms of peace and development can't exist together.

Activity Detail: - The purpose of the activity is to engage participants in research, analysis, critical thinking and reasoning. Through the medium of debate, they are required to express themselves succinctly using persuasive arguments, compelling evidence and the art of rhetoric.

Rules: -

1. The medium of debate is English.
2. A team of two participants from Classes XI -XII is eligible to participate in the competition, one in favour and the other against the motion on any one of the topics chosen by the team.
3. Each speaker will be given maximum 3 minutes to present his/her views. There will be a warning bell after 2 minutes and the speaker is expected to wind up within the next minute. The speaker will be negatively marked for exceeding the specified time-limit.

4. Participants are not permitted to carry any paper to the dais.
5. There will be a rebuttal round. Each speaker will be required to respond to an interjection from the members of the other participating teams in the audience within a minute.
6. The debaters will be judged by a distinguished panel of judges and their decision will be final and binding.
7. There will be three individual prizes for Debattons – Best Speaker (For), Best Speaker (Against), Best Interjector; and one Best Team Prize.
